# SCOPE AND CONTENT NOTE

This edition contains case files from the NAACP Legal Department for the northeastern states between 1956 and 1965. The cases involve the right to hold demonstrations, allegations of employment discrimination and police brutality, the integration of public school districts, and disciplinary actions against local NAACP branch leaders. The school district integration cases are by far the largest group of cases in the edition.

The NAACP Legal Department evolved as a major force in civil rights litigation after Thurgood Marshall separated the long-standing NAACP Legal Defense and Educational Fund (LDEF) from the NAACP proper in 1957. The separation was made in order to preserve the federal "tax exempt" status that the LDEF enjoyed as a nonprofit, nonpolitical arm of the NAACP. This tax-exempt status of the LDEF had been challenged by enemies of the NAACP because, as a spearhead for civil rights legislation, the parent organization was clearly political. After convincing the NAACP's Board of Directors of the need to separate the two organizations, Marshall's LDEF pressed ahead with litigation to bring nationwide compliance with *Brown v. Board of Education*. The LDEF also took up cases to vindicate voting rights, fair housing, and employment opportunities and to defend the constitutional rights of African Americans in criminal proceedings.

Robert L. Carter succeeded Marshall as General Counsel to the NAACP and served the corporate legal needs of the organization, which included adjudicating internal NAACP disputes and defending the association itself from hostile actions of state governments in the South. However, a neat division of labor between Marshall's LDEF and Carter's NAACP Legal Department was soon blurred. This was a result, in part, of Carter's responsibility to represent local NAACP leaders who, in their official capacity as branch presidents or state conference leaders, became involved in civil rights litigation. Some local leaders became embroiled in criminal prosecutions because of their civil rights work in the South. Carter's office therefore defended constitutional safeguards against false arrest and malicious prosecutions just as the LDEF did. In addition, local NAACP branch leaders spearheaded desegregation drives by filing as petitioners in cases. This also drew Carter's office into many of the same types of cases that Marshall was litigating through the LDEF, including school desegregation and desegregation of public facilities. However, another salient fact is that Robert

Carter strenuously disagreed with Thurgood Marshall that it was necessary (or advisable) to separate the LDEF from the NAACP. He was personally willing to have his office of General Counsel continue, in the tradition that Marshall had begun, as a resource in all cases where there was a promise of strengthening or attaining the legal rights of African Americans.

The cases microfilmed in this edition are, with few exceptions, cases that the NAACP Legal Department litigated in the states of Massachusetts, New Jersey, New York, and Pennsylvania between 1957 and 1965. The exceptions include a few cases that the Legal Department joined by filing *amicus curiae* briefs in support of public agencies that were sued by opponents of integration. The exceptions also include a reference file that Carter kept in a controversial employment discrimination case litigated by the American Jewish Congress (*American Jewish Congress v. Arabian American Oil Co.*). In addition, one North Carolina case file has been inadvertently filmed with the New York series of case files. This case, *Wilkins v. Williams*, involves a dispute between the NAACP and the leader of its Union County, North Carolina, branch. It is not known whether additional cases from the northeastern states will be deposited at the Library of Congress at some date in the future. This edition comprises the complete collection of Legal Department cases from Group V of the NAACP collection (1956–1965) for the northeast (defined as those states east of Ohio and north of Delaware).

Most of the cases involve school desegregation. Within a year or two after the U.S. Supreme Court decision in *Brown v. Board of Education*, it had become apparent to the NAACP that many northern communities were determined to avoid racial integration of public schools. The association assigned attorney June Shagaloff to investigate how these communities devised schemes to frustrate compliance with *Brown*. Shagaloff's memoranda and reports on northern school segregation can be found in *Papers of the NAACP, Part 22: Legal Department Administrative Files, 1956–1965*. The case files in this series document the legal thrust of the NAACP's campaign to root out northern school segregation. The cases challenge policies that Shagaloff's investigations pinpointed as the strategies for evading integration. They include definitions of school attendance boundaries, decisions on siting of new school buildings, and assignments and administration of pupil transfer requests. In some cases where it was impossible to alter these policies, the association petitioned for busing to achieve more integrated enrollments.

The cases are grouped alphabetically by state and thereunder alphabetically by the name of the petitioner. Massachusetts includes an extensive case on desegregation of schools in Springfield (*Barksdale v. Ryan*). There is also an extensive case file concerning the right to publicly demonstrate in Springfield. The latter case grew out of an allegation of police brutality (*Griffin v. Ryan*).

Both the New Jersey and New York files include extensive case files of school desegregation cases from almost every region of each state. In New Jersey, there are desegregation cases involving Orange (*Allen v. Board of Education* and *Fisher v. Board of Education*), Englewood (*Ancrum v. Board of Education*, *Fuller v. Volk*, and *Spruill v. Board of Education*), Plainfield (*Booker v. Board of Education*), Franklin Township (*Broadnax v. Board of Education*), and Bridgeton (*Byers v. Board of Education*). In addition, for New Jersey there is a case challenging the exclusion of African Americans from a realtors' association (*Dinkins v. Mercer Co. Board of Realtors*).

New York school cases appear from Rochester (*Aikens v. Board of Education*), Westbury (*Bailey v. Board of Education*), Brooklyn (*Balaban v. Rubin*), Babylon (*Bedford v. Board of Education*), Amityville (*Black v. Board of Education*), Manhasset (*Blocker v. Board of Education*), Hempstead (*Branche v. Board of Education* and *In re Vetere*), Roosevelt (*Bristow v. Board of Education* and *Squitiere v. Allen*), Glen Cove (*Davis v. Board of Education*), Buffalo (*Dixon v. Board of Education*), Malverne (*Mitchell v. Board of Education*), and New Rochelle (*Taylor v. Board of Education*).

There are also several employment discrimination cases from New York. These include *American Jewish Congress v. Arabian American Oil Co.*, *Board of Higher Education v. Carter*, *Gaynor v. Rockefeller*, *In re McCarther*, *In re Pygatt*, *Levin v. Local 1, International Longshoremen*, and *National Labor Relations Board v. Miranda Fuel Co.* Two New York cases involve questions of police procedure in criminal investigations. *Liebowitz v. Farmer* involves a police officer's libel suit against Congress of Racial Equality leader James Farmer who had charged the officer with police brutality. *People v. Whitmore* challenges an illegal arrest and admission of illegal evidence in a murder-rape case. Finally, the case of *Wright v. Rockefeller* alleges voter discrimination in congressional district definitions, while *Allen v. Hilton Hotels* complains of discrimination against African American hotel patrons.

The Pennsylvania series contains three large case files. *Chester School District v. Chester Branch, NAACP* concerns both school segregation and the right to demonstrate. *Collingsdale Federal Savings and Loan* also involves an attempt to restrain a demonstration. *Moore v. NAACP* is a protracted case on the removal of the Philadelphia branch president for anti-Semitic remarks and financial irregularities.

Throughout the entire collection, larger cases are typically subdivided into file series of Background Material, General Case Material, and Withdrawn Case Material. Background Material typically includes correspondence and exhibits. In school cases the exhibits sometimes include detailed sociological information of the local community or school system. General Case Material includes correspondence between the local attorneys or branch leaders and attorneys from Robert Carter's national office. Withdrawn Case Material includes legal documents such as briefs, motions, and depositions. Some



cases also include transcripts in the Withdrawn Case Material series. Finally, two cases (*Board of Education v. Carter* and *In re Vetere*) have oversized materials that were filmed on Reel 34.

Researchers should note that there are three companion editions of NAACP Legal Department files for the 1956–1965 period. *Part 22: Legal Department Administrative Files, 1956–1965* contains the complete deposit of Robert L. Carter's administrative office files for the period. This includes his general correspondence and memoranda files, subject files, and files in connection with adjudicating internal NAACP disputes. The correspondence and memoranda files may include material on cases or on communities that are part of this edition. In addition, there are two companion editions of case files organized by geographic region. These are *Papers of the NAACP, Part 23, Legal Department Case Files, Series A: The South* and *Series C: The Mid- and Far West*.

The records microfilmed for this edition come from Group V, Series B of the NAACP Collection held by the Manuscript Division of the Library of Congress, Washington, D.C.

## **EDITORIAL NOTE**

This edition was compiled by Professors John H. Bracey Jr. and August Meier after a complete survey of the records of the NAACP Legal Department for the period before 1965 deposited at the Library of Congress and classified as Group V of the NAACP collection. Every northeastern case file was selected for the edition. Each file has been microfilmed in its entirety.
