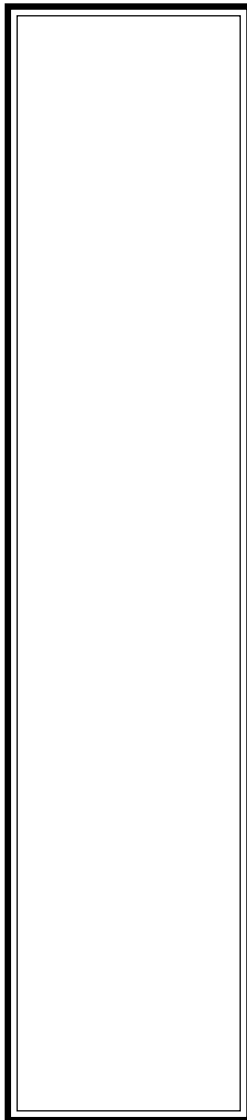

SCOPE AND CONTENT NOTE

Shortly after midnight on July 15, 1967, just two weeks after a week-long riot on Buffalo's predominantly black east side, a group of Buffalo police, New York State troopers, and a federal law enforcement official entered the Afro-Asian Book Store owned by Martin Sostre. No one in the store at the time agreed on what happened next. Whether the police attacked Sostre or Sostre attacked them, at the end of the raid, the police arrested Sostre, his coworker Geraldine Robinson, and three others in the store. They charged Sostre with inciting persons to riot, arson, possession and sale of narcotics, and resisting arrest. A grand jury later indicted Sostre on the narcotics charge and for second degree assault. Over the course of his initial criminal trial, Sostre repeatedly argued that the police were framing him in order to close down his book shop, which specialized in radical political literature. In March 1968, Sostre was sentenced to thirty to forty-one years in prison. In June, he was placed in solitary confinement at Green Haven Prison, where he remained for thirteen months.

The case of Martin Sostre is just one of many interesting cases reproduced in this edition of *Papers of the NAACP, Supplement to Part 23: Legal Department Case Files, Series B: The Northeast, Section II: New York*. The documents in this section consist of the working case files of the NAACP's general counsel and legal department staff for New York State. The major topics covered in these cases are discrimination in housing, employment, and education. The cases are organized alphabetically by case name.

The documents from the Sostre criminal trial, *People v. Sostre*, include trial transcripts that indicate a tense courtroom, and materials from five cases initiated by Sostre while in jail. The files also contain correspondence between Sostre and NAACP attorney Joan Franklin. The NAACP represented Sostre's coworker Geraldine Robinson and in May 1968, Sostre began to correspond with Franklin. The NAACP initially saw eye to eye with Sostre. In a July 1968 memorandum from Franklin to NAACP General Counsel Robert L. Carter, Franklin wrote that Buffalo police appeared to be on a campaign "to destroy ... the most vocal black militant in the Buffalo area," and she compared Sostre's case to police targeting of other African American radicals like Eldridge Cleaver, Huey Newton, and LeRoi Jones. Franklin further argued that it made sense for the NAACP to get involved on behalf of Sostre in order to stop "in legal fashion politically motivated attacks on the black community" (Reel 29, Frame 0711). Two years later, however, Sostre accused Franklin of "turning to the right" and in July 1970 he requested that she withdraw from

his case (Reel 30, Frames 0492 and 0600). In August 1970, Sostre wrote to NAACP Executive Director Roy Wilkins and accused the NAACP of abandoning the “black masses” and “aiding the white racist oppressor” (Reel 30, Frame 0600). After this letter from Sostre, the NAACP, not surprisingly, seems to have lost interest in the case, and the quantity of material from 1970 to 1973 is significantly smaller than the documentation for 1967 to 1970. Still, the NAACP continued to collect some documents on the case, including materials when Sostre’s claims of a set-up eventually came to light. In 1973 police informant Arto Williams admitted that, in order to get out of his own legal troubles, he had agreed to help police frame Sostre.

Only four cases in this edition pertain to discrimination in housing, but these cases account for approximately twelve of the thirty-five reels in the collection. In *Margulis v. Lindsay*, Anita Margulis, together with the Association of Old Forest Hills, Inc., sued the mayor of New York, John V. Lindsay, and the chairman of the New York City Housing Authority, Simeon Golar, to prevent the construction of low-income public housing in the town of Forest Hills. The development was part of the New York City Housing Authority’s attempt to implement plans for “scatter-site” public housing. The plans met resistance from local homeowners who did not want public housing built in their affluent neighborhoods. The files for this case include an investigation of the project by Mario Cuomo and the NAACP’s amicus curiae brief supporting “scatter-site” public housing.

By far the largest single case in this edition is *Fair Housing Development Fund Corporation v. Burke*. This case had its origins in an August 1968 study carried out by the Glen Cove NAACP branch. The study aimed to find out why such a small number of African Americans lived in the town of Oyster Bay. The next year, Glen Cove NAACP branch president James Davis, together with NAACP director of housing William Morris and regional field director Jerry Guess, met several times with Oyster Bay officials to discuss the town’s zoning laws. When Oyster Bay refused to change its land use and zoning ordinances, the NAACP assembled a group of plaintiffs and sued Oyster Bay Mayor Joseph W. Burke, arguing that these laws denied lower income African Americans access to housing opportunities. In the suit, the NAACP asked the court to declare Oyster Bay’s zoning ordinance unconstitutional and to devise and implement a plan for integrated housing. Beginning on Frame 0182 of Reel 8 and continuing through to Frame 0119 of Reel 17, documents on this case consist of Oyster Bay Board meeting minutes, newspaper clippings, population statistics, housing and land use reports, excerpts from decisions in related cases, and court documents, including affidavits, depositions, exhibits, interrogatories, and transcripts of the court proceedings.

The two other discrimination-in-housing cases in the edition are much smaller in size but still address important legal questions. Zoning laws were again an issue in *Welch v. Dzaluk*, a case from Westchester County. In 1963, the Union Free School District No. 4 opened a newly constructed junior high school and permanently closed the Old Port Chester Junior High School. The old junior high school remained vacant and unused from 1963 to 1969. In October of that year, the Board of Education of

Union Free School District No. 4 asked the Board of Trustees of Port Chester to change the zoning of the Old Port Chester Junior High School site to allow for the construction of a maximum number of multifamily dwellings. In January 1970, the Port Chester Board rejected the Board of Education's proposal. As a result, the Board of Education decided to sell the land to a private developer. Mozella Welch and her fellow plaintiffs, all residents of Port Chester, sued Joseph Welch, the mayor of Port Chester, as well as the Union Free School District, in an effort to prevent the land sale to the private developer. They argued that such a sale would "perpetuate the housing segregation ... by race and poverty and deny ... equal residential housing and land use opportunities" (Reel 35, Frames 0470-0471).

In *Davis v. Sesti & Sons*, Eleanor Davis attempted to rent an apartment located over a bar in Centerport, New York, from Pat Sesti. When Davis went to Sesti's office, his secretary informed her that he did not wish to rent the apartment to a woman living with two children. Two days later, Sesti rented the apartment to Davis's white friend, who would be living with her three children.

Discrimination in employment remained an important concern of the NAACP in the late 1960s and 1970s, and this edition contains twenty-seven cases on the topic. Three of these cases illustrate the variety of occupations and issues involved. In 1964, the State Commission for Human Rights sued Local 28 of the Sheet Metal Workers' International Association of Greater New York and its president, Mell Farrell, to stop the union from discriminating in the selection of candidates for its apprenticeship program. Two years later, in November 1966, the union administered an aptitude test for admission to its apprenticeship program. Persons passing the aptitude test were automatically admitted to the union's apprenticeship program. One hundred forty-seven applicants took the November test, including thirty-two African Americans. Sixty people passed the test including twenty-four African Americans, and African American applicants received twelve of the fifteen highest scores on the test. Apparently not prepared to accept twenty-four African Americans into their recruitment class for 1967, the union and the Joint Apprenticeship Committee announced in December 1966 that they would invalidate the test results and order a retest. The State Commission for Human Rights stepped in at this point and again took the union to court.

In *Minor v. Long Island Railroad*, the Long Island Railroad dismissed Sam Minor from his job because of his alleged drug abuse. Minor was a Vietnam veteran and had suffered a shrapnel wound on his left foot. This wound flared up in the summer of 1972, and Minor took sick leave from August 18 until October 15. During his time on sick leave, the Long Island Railroad required Minor to meet periodically with the company's medical director. According to Minor, the medical director, Dr. Mark E. Fox, tried to have Minor dismissed from employment because of a heart murmur. Minor, however, was examined by an independent cardiologist who disagreed with Fox's diagnosis. Minor said that Dr. Fox then attempted to dismiss Minor on a drug abuse charge. At this point Minor went to the New York State Division of Human Rights. He argued that his "drug abuse dismissal was racially motivated" because

Minor thought the Long Island Railroad “believed Black Vietnam veterans to be drug users.” Minor claimed the real reason for his dismissal was that he was training for the position of engineer and that the railroad was engaged in “a systematic effort to exclude Blacks from the positions” (Reel 24, Frame 0119).

In August 1972, Winston M. Clarke, a corrections officers at the Rikers Island Hospital, part of the New York City correctional system, accused Captain Jay Goggins of assault. Clarke reported the incident, and later Clarke was involuntary transferred to the Bronx House of Detention, while Captain Goggins faced no disciplinary action. In *Clarke v. New York City Department of Corrections*, Clarke charged that the disparate treatment given to him and a white officer constituted employment discrimination under the New York State Human Rights Law.

Of the seventeen cases relating to discrimination in education and school desegregation, eight come from Long Island and six from New York City, including three Brooklyn cases. The other three cases are from Newburgh, Syracuse, and Utica. In 1963 and again in 1964, the Roosevelt School Board crafted plans to eliminate segregation in the district schools. The plans, however, met with opposition from white residents and were never implemented. In July 1965, in *Bristow v. Board of Education*, parents of African American children in the Roosevelt schools, represented by the NAACP, sued to eliminate segregation in their district. In another Nassau County case, *In re Mitchell*, the Board of Education attempted to circumvent a state-ordered integration plan by adopting a freedom-of-choice plan. *Olson v. Board of Education* covers the same school district and includes an amicus brief submitted by Patricia Ann Mitchell, the plaintiff in *In re Mitchell*. In *McCoy v. Wheaton*, the NAACP wanted to dissolve the predominantly black Wyandanch school district to achieve desegregation, but the district principal, James Lewis Jr., an African American, disagreed with the NAACP position. Lewis argued that the NAACP decision would mean that the Wyandanch parents would lose control of their children’s education.

This issue of community control also surfaced in Brooklyn in what became a bitter dispute between the Ocean Hill–Brownsville Governing Board, the New York City Board of Education, and the United Federation of Teachers. Reverend Milton Galamison of the Siloam Presbyterian Church and former president of the Brooklyn NAACP branch, together with other Brooklyn residents and parents with children in the Brooklyn schools, filed suit in *Galamison v. Board of Education* in May 1966 to desegregate the Brooklyn schools. In September 1967, however, as part of a movement for decentralization and community control of New York City schools, a local board took over the administration of schools in the Ocean Hill–Brownsville district of Brooklyn. The following May, Rhody McCoy, the head of the Ocean Hill–Brownsville Governing Board, informed eleven teachers that he was terminating their employment. As recounted in the case materials for *United Federation of Teachers v. Board of Education of the City of New York* (Reel 34, Frame 0310), tensions rose quickly with a student boycott, physical abuse of the teachers, and demonstrations outside the school and in front of the Board of Education headquarters. The United

Federation of Teachers informed the New York City Board that it would call a citywide strike if the fired teachers were not reinstated in another part of the school system. In October 1968, the New York City Board suspended the Ocean Hill–Brownsville Board. The Ocean Hill–Brownsville Governing Board responded by filing suit. In *Ocean Hill–Brownsville Governing Board v. Board of Education*, the plaintiffs sued claiming that the board’s suspension denied them their due process rights guaranteed by the Fourteenth Amendment to the U.S. Constitution. The NAACP represented the Ocean Hill–Brownsville Governing Board.

Other interesting cases in this edition include the Columbia University demonstration cases, *Cooper v. Power*, *In re Moore*, and *People v. Pickett*. In the spring of 1968, several days of demonstrations threw the Columbia University campus into turmoil. Over two hundred students occupied the office of Columbia University President Grayson Kirk. African American students at Columbia University, together with local residents, took over Hamilton Hall, the building housing the university’s administrative offices, to protest university expansion into the Morningside Heights neighborhood and the university’s ties with the Institute of Defense Analysis. The NAACP represented fourteen of the students in their criminal cases. In *Cooper v. Power*, Andrew Cooper, together with other citizens of the Bedford-Stuyvesant neighborhood in Brooklyn, sued the members of the New York City Board of Elections and other state and local officials. The plaintiffs contended that the congressional district lines for their neighborhood were part of a “racially motivated and invidiously discriminatory scheme” to deny them their equal voting rights (Reel 7, Frame 0112). They asserted that the division of the Bedford-Stuyvesant area, a predominantly African American and Puerto Rican neighborhood, into five different congressional districts deprived them of their right to vote under the Fourteenth and Fifteenth Amendments to the U.S. Constitution. In an affidavit for this case, NAACP Executive Director Roy Wilkins argued that an “obviously irrational gerrymander” had been drawn “for the purpose of diluting the political strength” of the African American residents of Bedford-Stuyvesant (Reel 7, Frame 0246). The files for this case also include the NAACP’s amicus curiae brief in support of the plaintiffs.

In re Moore involved an attempt by members of the Philadelphia NAACP branch to oust their radical branch president. On August 2, 1967, members of the Philadelphia NAACP branch filed four charges against branch president Cecil B. Moore. According to the complaint, Moore had violated NAACP policy by engaging in partisan political activity, endorsing the candidate of an all-black political party, failing to comply with NAACP fund-raising rules, and using “vile, abusive, threatening, and profane language” while speaking as an officer of the NAACP (Reel 25, Frame 0056). In *People v. Pickett*, Mose Pickett, a welfare recipient living in Niagara Falls, received a thirty-day jail sentence for refusing to take a landscaping job that paid \$1.50 per hour, a job that his welfare case worker had selected for him. The NAACP submitted an amicus curiae brief in the case arguing that Pickett’s imprisonment constituted a violation of the involuntary servitude provision of the U.S. Constitution’s Thirteenth Amendment.

This edition of *Papers of the NAACP* represents the fifth section of legal case files microfilmed by LexisNexis focusing on the period after 1965. Other parts of *Papers of the NAACP* that contain significant documentation on the NAACP Legal Department are *Part 23: Legal Department Case Files, 1956–1965*; *Part 22: Legal Department Administrative Files*; and *Supplement to Part 16: Board of Directors File, 1966–1970*.
